Call to Order:

The meeting was called to order at 10:03 am by Cornelius Sanders.

Review and Approval of Minutes:

The minutes from the last MSCHC Quarterly Consortium meeting in March 2020 were reviewed. With a motion from Mary Hamlett and a second from Emily Connell the minutes were approved as presented.

Presentation: Consortium Year in Review


Cornelius presented on some of the accomplishments of the Homeless Consortium in the past year, including:

- Over 38 committee meetings with over 600 attendees
- Successfully completed Point-in-Time Count with over 125 volunteers
- Over 145 individuals were trained in various topics including Housing First, Harm Reduction,
 Trauma Informed Care, and Motivational Interviewing
- 848 families and individuals were assessed for services
- 85 individuals regularly entering data into HMIS
- Our CoC scored in the top 50% and above the weighted mean score of all CoCs nationwide on the collaborative application and System Performance Measures
- \$6.9 million awarded in CoC funding to 31 projects across 13 agencies
- COVID-19 response has been a true community-wide effort because of our partners
- New and renewed partnerships with agencies and service providers during COVID-19 response that will strengthen our system

In November, the group had a visit from American Job Center reps and discussed how to connect consumers who have criminal backgrounds and learning challenges to employment opportunities. In March, the group conducted a survey among committee members, which revealed that connecting consumers to non-employment income is working but could be better.
- <u>Veterans Committee</u>: Emily Connell reported that the Veterans By-Name List is continuing to operate with weekly check-in meetings with veteran service providers.
