

# **Coc Planning Meeting Minutes**

#### Call to Order:

The meeting was called to order at 10:03 am by Mia Cotton.

## Review and Approval of Minutes:

The minutes from the last CoC Planning meeting in August were reviewed. With a motion from Ceaira Brunson and second form Shirleyn McClain the minutes were approved as presented.

#### **Presentations & Discussion**

# a. 2021 CAFTH Gaps Analysis

Grant Ebbesmeyer went over the 2021 Gaps Analysis. Surveys found that the average length of time homeless (LOTH) for single adults was 2+ years, and the LOTH for families with children averaged around a few weeks. The highest barrier to housing was loss of job/employment (this contradicts a common misconception that the highest barriers to housing are substance abuse or mental disorders). When comparing the HUD FY21 CoC dollars awarded by city, Memphis at \$7M receives much less than similar cities like Buffalo \$13M, New Orleans, Detroit and Cleveland \$31M. Single adults are at highest risk for exit to unsafe or unknown destinations (unknown is the highest). There is a lack of funding dedicated for single adults in Memphis/Shelby County. Surveys verified the existence of a large racial disparity, and found that a majority of individuals experiencing homelessness were black, indigenous, persons of color (BIPOC).
